4、测试方法 Test Method

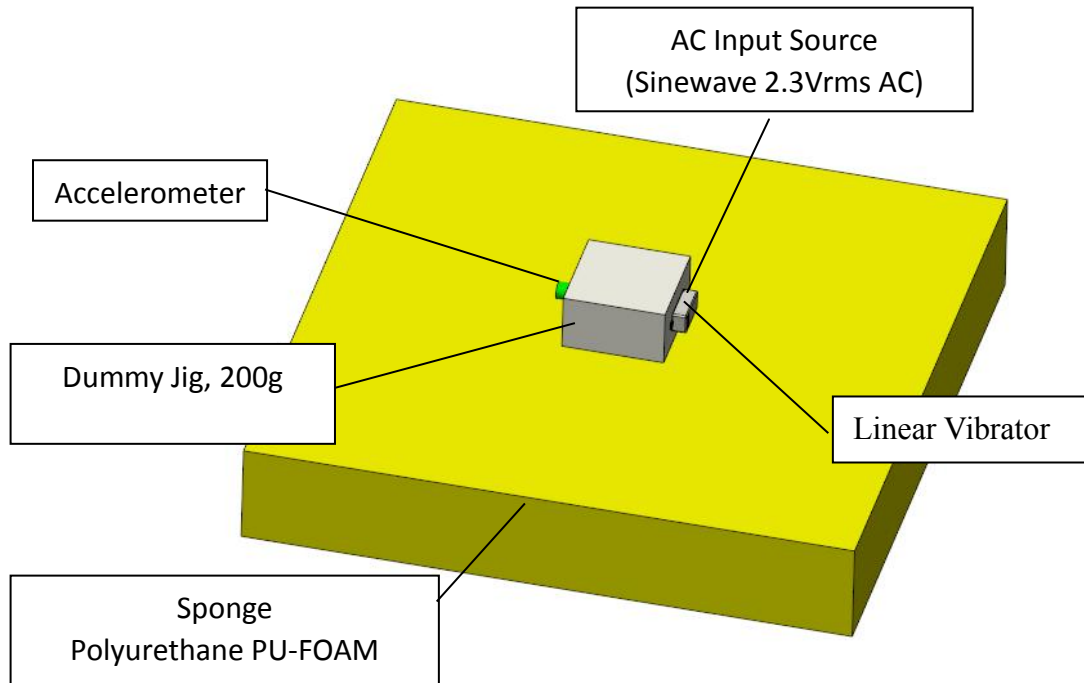


Figure 1. Test method

- Attach accelerometer and vibrator on the position on dummy jig according to the figure 1.
将测试马达和加速度传感器按照上图指定尺寸位置固定好
- Acceleration of linear vibrator should be measured 2~3 second later when source inputed.
接通后 2-3 秒后读数.
- At measurement of acceleration, test jig and accelerometer should be stabilized.
测试过程中，传感器与测试治具要固定牢固.
- For the precise measurement, acceleration of linear vibrator is average data.
为了测量数据准确，振动量数据取平均值.
- If the judgment is not questionable, recognize measurement at 5°C to 35°C & relative humidity 45%RH to 85%RH.
在不影响判定结果的情况下，测试环境温度 and 湿度可以放宽至 5-35°C，45%-85%RH.

7、可靠性试验判定 Requirement Reliability Test Judgment

7-1 以下条件必须在测试结束后满足/After test, following specifications must be satisfied.

F0 点振动量/Acceleration: 初始值/Initial Value $\pm 30\%$

F0: 初始值/Initial Value $\pm 10\text{Hz}$

额定电流/Rated current: Initial Value $\pm 30\%$

噪音/Noise: 50dB(A) Max at 30cm distance

7-2 试验完毕后需在标准测试条件下放置 2 小时后再测试。

The measurement is conducted after 2hours of recovery under standard test condition after reliability test.

7-3 外表和结构无异常。

There should be no abnormalities in appearance and structure.

8、注意事项 Caution for Use

8-1 不要在如下条件下使用马达，它将降低产品的性能甚至马达损坏。

Don't use under the following conditions. It may cause decline of performance or damage.

8-1.1 不要将产品放入例如水，酒精等液体中。

Do not drop into fluid (such as water, alcohol, etc)

8-1.2 不要将产品长期置于高温高湿条件下。

Do not keep at high temperature or high humidity for extended periods of times.

8-1.3 不要将产品靠近腐蚀性气体。

Do not use near gasses which cause erosion.

8-2 马达的额定电压为 2.3V，工作电压为 0.1~2.35V，实际使用中马达最大驱动电压不能超过 2.35V。

Motor rated voltage is 2.3V, working voltage is 0.1~2.35V, so motor drive voltage can not exceed 2.35V.

8-3 马达的额定驱动信号为交流正弦波，推荐使用标准信号进行马达驱动。

Motor driving signal should be AC sine wave.

8-4 在存储、运输和使用的过程中不要将产品靠近磁性设备。

Don't make the product near magnetic devices in the process of storage, transportation and use.

8-5 这款马达有强磁性，使用的时候需要注意。

The vibrator has a strong magnet, please pay attention to it.

8-6 马达固定时，振动方向上必需固定好(安装力推荐 5~8N)，否则将容易引起噪音。

Vibrator should be fixed to house firmly in vibrate direction (setting force 5~8N), or it will be easy to cause noise.

Use double side adhesive to fix the motor, Soft material (such as poron, poam etc.) can be used to provide setting pressure.

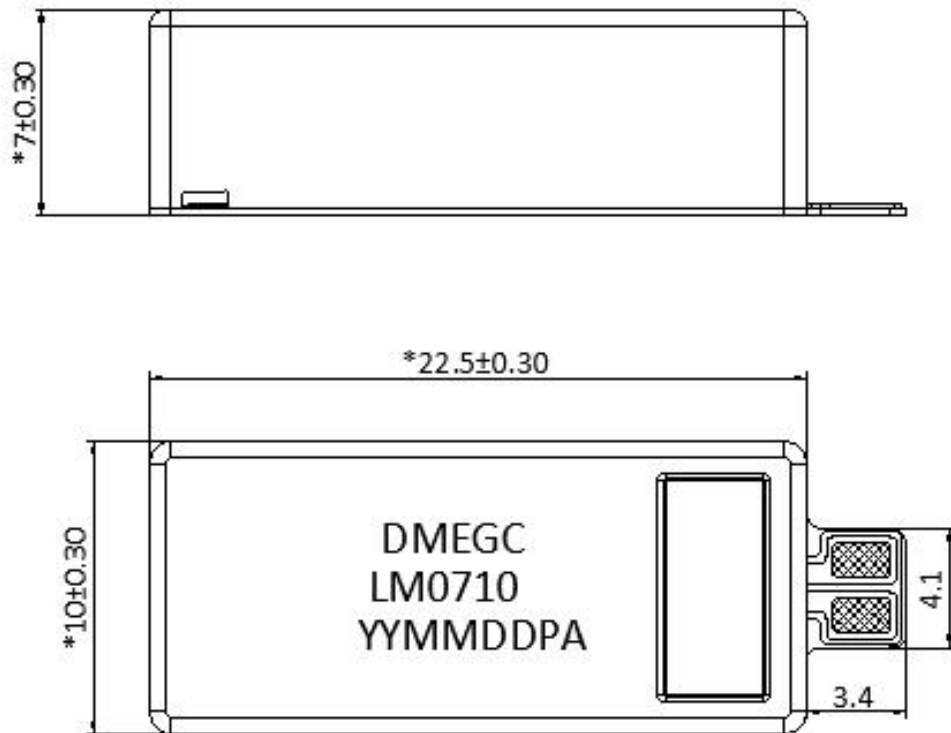

10、包装规范 Packing Specification

1、一箱内包装 400PCS。

Pack 400 pcs in a carton

2、箱体规格为 420mm×320mm×145mm (400 PCS 装)。

The body specification of the case is 420mm×320mm×145mm (400pcs).

3、单盒为 10PCS 标准，一匝为 10 盒 100PCS 标准，一箱为 4 匝 400PCS 标准。

The single box is 10 pcs standards; one circle is 100 pcs standards of 10 boxes, a case is 4 circles with 400 pcs standards.

4、内包装吸塑盒、外包装双层瓦楞箱。

The internal packing is plastic box while the external packing is double corrugated box.
